Capt. Kenny Krulish, age 49, of St. Augustine, passed away unexpectedly on January 22, 2013. Kenny was born and grew up in Jacksonville, and was a 1980 graduate of Clay High School. He served his country in the U.S. Navy and soon after began his career as a firefighter in St. Marys, Georgia. In 1988, he became employed with St. Johns County Fire Rescue working an ambulance for SJC EMS. Since that time Kenny has progressed through the ranks, currently holding the rank of Captain, in the North-Central District at Station 15. Captain Krulish has always been an active and well respected member of his department serving in many roles in both the Administrative and Operations Sections of the Department. Of his numerous accomplishments, he most enjoyed helping develop the training division at St. Johns Co. Fire Rescue and training firefighters throughout the state for more than 10 years. On a personal level, Kenny was known as a man of strong faith and integrity, and he was an active member of Anchor Faith Church. Above all, he loved and cherished his family with whom he enjoyed spending as much time as possible. He will be forever remembered as a devoted husband and loving father, and he will be deeply missed by all who had the privilege of knowing him.
