John David "Jack" Evans, age 78, of St. Augustine, passed away on January 5, 2012 at Kindred Hospital of North Florida in Green Cove Springs. Born and raised in Utica, New York, he first earned an Associates Degree at Mohawk Valley Community College, before receiving his Bachelor of Science Degree and Masters Degree from the State University of New York in Albany. Jack worked at several jobs, including General Electric Co. in Schenectady, NY, and in retailing, as well as serving as a male nurse at the Leonard Hospital in Troy, NY. However, he spent most of his adult life as the Head of the Business Dept. at Scotia-Glenville High School, where he taught for thirty-two years. Jack also worked as a real estate agent for many years in the Scotia, N.Y. area, before moving to St. Augustine in 1985. Jack loved to travel in both the U.S. and in Europe, and will also be remembered as one who thoroughly enjoyed jitterbug dancing. He was a huge supporter of the National Cystic Fibrosis Foundation, and a member of both the Lions International and Rotary International. Additionally, he was a faithful member of St. Anastasia Catholic Church. Jack was a loving husband and father, and he will be deeply missed. He is survived by his wife of 58 years, Helen Elizabeth "Beth" Evans of St. Augustine; daughters, Mary Cox (John) of Millersville, Maryland and Katherine Champagne (Ken) of Latham, NY; sons, John D. Evans, Jr. (Donna) of Raleigh, NC, Kenneth Evans (Sandy) of Delmar, NY and David Evans (Jaime)

of Albany, NY; a brother, Richard Evans of Washington Mills, New York, and his 11 grandchildren. Funeral Services will be held at 9:00 a.m. on Tuesday, January 10, at St. Anastasia Catholic Church with Father Terrence Morgan officiating. Interment will follow at San Lorenzo Cemetery.
